EXECUTIVE SUMMARY

1. LGBTI PORTUGAL: A MIXED PICTURE

Since the end of Portugal's dictatorship in 1974, particularly in the last two decades, the country made accelerating progress on LGBTI rights, particularly for a long-closed country and conservative culture. As a result, in 2019, Portugal ranked #7 on ILGA Europe's Rainbow Map. However, Portugal remains with Eastern Europe near the bottom of OECD countries for LGBTI social acceptance. Stigma, discrimination, isolation, and victimisation remain the reality of many.

2. BIDDERS: A TRIO OF SYNERGIES

Portugal's EuroPride 2022 bid represents a joint effort by three national organisations who, together, offer LGBTI people a path to self-determination, autonomy, and community in all aspects of life. ILGA Portugal is the country's largest and oldest NGO working for the social integration of and an end to discrimination against LGBTI people and their families. rede ex aequo promotes social integration and recognition of the needs specific to LGBTI youth through a network of local support, social, and activism groups. Variações promotes LGBTI economic empowerment by helping LGBTI-owned/-focused small businesses in Portugal, and employees and associations at larger firms.

3. CONCEPT: BEYOND PROUD

The vision of a pan-European Pride movement will mark 30 years in 2022 since the first EuroPride march took place in London. In 2022, we will celebrate not just Pride, but pride in our accomplishments as a movement that has changed the landscape for LGBTI lives in Europe. At the same time, such a landmark anniversary invites us to look forward, to see how we can **expand** the vision of EuroPride beyond today and beyond boundaries, in order to transform LGBTI lives beyond recognition.

4. PROGRAMME: 6 DAYS, 2 CITIES, 1 DESTINY

EuroPride 2022 Portugal takes place Monday-Saturday, 19-24 September. The Human Rights Conference opens the evening of Monday, 19 September in Porto. The EuroPride Village in Lisbon opens to visitors the afternoon of Thursday, 22 September, with a party that night. Special rail offers facilitate the 2.5-hour trip between Porto and Lisbon during the week, with capacity added Lisbon-bound the last day of the conference. EuroPride culminates with the march on Saturday, 24 September, which delivers festival goers to the EuroPride Village for the closing and handover ceremonies, and the main concert.

Both cities will host an **Espaço EuroPride** mixed-use event space near the official event venues. Open all week, these will house an educational exhibition, be available for receptions, and performances, and to groups wishing to organise meetings and workshops in relation to EuroPride. In addition, businesses and arts institutions across both cities will be engaged to develop a EuroPride-related social and cultural agenda to accompany the political events.

5. BUSINESS PLAN: SUSTAINABLE SUCCESS

EuroPride 2022 Portugal public events, including the Human Rights Conference will be **free to attend**. In addition, our planning includes helping students in particular with accommodations in order to **make youth participation a priority**.

EuroPride 2022 Portugal will be marketed as a single, contiguous, 6-day festival that begins in Porto and ends in Lisbon.

Communications will take a digital-first, substance-first approach, timed with the calendar of European and worldwide LGBTI events from 2019 to 2022. Social platforms (Facebook, Instagram, etc.) will serve for audience-capture and as extensions of the EuroPride 2022 website and app. By going beyond promotion and information to deliver added-value knowledge, we will position EuroPride 2022 as a must-attend event.

Faithful to our Beyond Proud concept for EuroPride to be a positive force for communities, we will design a social and environmental programme to guide our efforts. We will aim to meet **B Lab standards for sustainability and inclusivity** the full length of our supply and value chains, and encourage our vendors and partners to do the same.

6. PORTUGAL: #1 IN LGBTI TRAVEL

Renowned for its warm weather and warm welcome, Portugal is among the 20 most visited countries in the world, receiving an average of 13 million foreign tourists annually. Ranked among the five most peaceful countries in the world, Portugal also tied for #1 on the 2019 Spartacus Gay Travel Index. Since five years, Portugal consistently features among Top-10 destinations, on both professional (Monocle, Lonely Planet, Conde Nast Traveller, etc.) and user-generated (TripAdvisor, Airbnb, etc.) lists.

While the need for greater LGBTI social acceptance and legal equality is acute, openness to foreigners and a culture of respectfulness mean that Portugal remains among the safest, most **welcoming places** for LGBTI travelers. Lisbon and Porto have dynamic, visible LGBTI presence, and initiatives in smaller cities are multiplying rapidly as evidenced by the local Prides and EPOA members emerging in the last two years.





1.LGBTI PORTUGAL: A MIXED PICTURE

Since the end of Portugal's dictatorship in 1974, particularly in the last two decades, the country made accelerating progress on LGBTI rights, particularly for a long-closed country and conservative culture. By 2019, Portugal ranked #7 on ILGA Europe's Rainbow Map and tied for first on Spartacus Guides ranking of LGBTI travel destinations.¹ However, Portugal also joins Eastern Europe near the bottom of OECD countries for LGBTI social acceptance.² Stigma, discrimination, isolation, and victimisation remain a daily reality for many.



SUCCESSES AND OBSTACLES


While Portugal's LGBTI civil society fosters best practices and achieves legal and political advances, the law still does not protect equal access to goods and services, healthcare and employment. Legal protection against hate crimes and for asylum seekers is incomplete. Bullying in schools and lack of LGBTI education persist. Especially outside the major cities of Lisbon and Porto, much work remains in order to overcome cultural inertia and prejudice, which continue to hamper LGBTI security, equality, access, and inclusion.

Portugal thus forms a bridge between more and less advanced European countries in terms of LGBTI equality. Portugal's

successes can serve to inform and empower political activism in other conservative societies, where progress is most urgent. Portugal's lapses, meanwhile, remind even its more advanced peers to translate policy progress into everyday experience.

EuroPride would show Portugal the value, beauty and power of diversity. EuroPride would federate the slowly emerging crop of local Prides and LGBTI initiatives across Portugal, giving sustenance and permanence to a national movement that will inspire others. EuroPride would help ensure that headline progress does not remain confined to paper.





Founded in 1995, ILGA Portugal belongs to the ILGA Europe Advocacy Network, is a founding member of NELFA, an IDAHO correspondent, and a member of FRA's Fundamental Rights Platform and of the Advisory Council of the Portuguese Commission for Citizenship and Gender Equality. Based in Lisbon, ILGA Portugal coordinates groups devoted to specific topics, such as Lesbian or Trans issues and Rainbow Families, and key initiatives including:

- **Political intervention:** Lobbying Portuguese political parties and the Government, building alliances with private and public institutions, organizing conferences and promoting petitions, among other activities.
- Arraial Lisboa Pride: The largest annual LGBTI Pride event in Portugal. Integrated in the Festas de Lisboa municipal festival, the party takes place on Lisbon's main square. Live performances, DJ's and a Pride village including stands for NGOs and LGBTI businesses draw around 70,000 attendees each year.
- LGBT Centre: A helpline, psychological and legal counseling, HIV and STI prevention, social integration assistance for asylum seekers and refugees, a documentation centre on LGBTI issues and victim support, many cultural and political events, and opportunities for supervised training and volunteer work.
- **Prémio Arco-Íris:** Annual Rainbow Awards ceremony honours people or institutions whose work throughout the year promotes the fight against discrimination based on sexual orientation, gender expression and identity, and sex characteristics.
- Information: Publications on LGBTI rights and access to resources, multimedia campaigns against LGBTI discrimination, education and training of professionals to ensure LGBTI access to public services.



President - Nuno Pinto

Nuno Pintois an LGBTI activist and volunteer with ILGA Portugal since 2005, and a member of the Board of which he is now President since 2011. Nuno holds a degree in political psychology and does research in the field of social sciences. He has a PhD from ISCTE Lisbon University Institute, with a thesis on the situation of Trans people in Portugal, and works on national and international projects involving both research and intervention in LGBTI domains.



Executive Director - Marta Ramos (Co-President of EuroPride 2022 Portugal)

With a background in Law and a major in Human Rights, Marta Ramos is the Executive Director of ILGA Portugal. She previously worked at the Office of the Council of Europe Commissioner for Human Rights, in the European Parliament and at the Portuguese Commission for the Citizenship and Gender Equality. Marta is a member of ILGA Portugal since 2011, where she developed specific work and expertise on combating and raising awareness of anti-LGBTI hate crimes, particularly via projects with the Observatory on Discrimination and UNI-FORM.



rede ex aequo began informal activities in 2002 through the Descentrar Project of ILGA Portugal, funded by the Portuguese Institute for Youth. It was formally organised in 2003 and attained legal status in 2004. rede ex aequo's mission is to:

- Fight discrimination, and promote social integration and recognition of the needs and specificities of LGBTI youth
- Implement strategic scientific, social, cultural, and political interventions on behalf of LGBTI youth and education
- Create and foster the development of local support, social and working groups for LGBTI youth and supporters

The association runs support centres, activism and social programmes throughout the country. rede ex aequo also organise discussions and clarification sessions in schools about sexual orientation, gender identity and expression. Victims can report instances of homophobic or transphobic bullying to the association's Observatory. rede ex aequo also offer support and information for family and friends of LGBTI young people.

rede ex aequo is inscribed in the National Register of Youth Associations and is part of the National Youth Council, the Forum for the Rights of Children and Youth, and the International Lesbian, Gay, Bisexual, Transgender, Queer Youth and Student Organisation (IGLYO).



President - Tavares

Tavares is an activist and volunteer with rede ex aequo since 2016. Tavares is currently Chair of the Board. Tavares studies leisure management and tourism and works actively in projects related to the protection of LGBTI youth and sex education in schools.



Vice President - Isaac Rodrigues

Isaac Rodrigues began activism with rede ex aequo in 2014. Isaac has been an active volunteer ever since, having been appointed as Treasurer of the Board and currently serving as Vice President. Isaac is dedicated to projects involving Trans youth.

Founded in 2018, Variações: LGBTI Business & Tourism Association of Portugal unites more than 60 firms in a non-profit association that supports LGBTI economic empowerment in Portugal. The core membership consists of LGBTI-owned, -managed, and -focused small businesses working to establish Portugal both at home and abroad as a top destination for LGBTI residence, travel and investment. Promoting Portugal as a hub for the worldwide LGBTI community also promotes a culture of inclusivity within Portugal by using economic incentives to advance social goals. To do so, Variações engages with LGBTI groups at large firms and with public authorities to support diverse and inclusive workplaces, labour and business practices, and legislation.

Variações' first year operating budget was approximately EUR 20,000 from membership fees and voluntary contributions to specific initiatives. Government grants for Variações' second year increased this amount more than ten-fold, reflecting the Government's commitment to a strong LGBTI economy in Portugal.



President - Carlos Sanches Ruivo (Co-President of EuroPride 2022 Portugal)

Carlos Sanches Ruivo, 51, is a co-founder and current President of Variações, and founder of The Late Birds Lisbon, Portugal's largest LGBTI hotel company. Carlos graduated in Telecom Engineering in Paris, where he worked for 20 years before pursuing his MBA and starting The Late Birds. Having spent 38 years abroad and as an activist, mostly in French LGBTI political and sports organisations, Carlos is now an active leader of Portugal's LGBTI community, and The Late Birds both serves as a hub for the LGBTI community in Lisbon and sponsors many cultural, social, athletic, and charity events throughout the year, such as the Queer Film Festival, Fado Bicha and Portugal's participation in the 2018 Paris Gay Games.



Executive Director - Diogo Vieira da Silva

Originally from Porto, Diogo Vieira da Silva, 29, is a co-founder and current Executive Director of Variações. Diogo became an LGBTI activist at a young age, having joined several projects, including leading Portugal in the European coordination of the It Gets Better Project, which ran from 2017 to 2018. Diogo is Assistant General Manager at The Late Birds Lisbon. He holds degrees in Hospitality Management, International Trade and Digital Marketing.

CIVIL SOCIETY ADVISORY COUNCIL

The Civil Society Advisory Council has a three-fold role:

(1) to include perspectives from the full spectrum groups based on identity, issue and geography across Portugal;

(2) to engage the community beyond the major cities and beyond the most established LGBTI civil society issues and actors in a collective effort behind EuroPride;

3.CONCEPT: BEYOND PROUD

In a survey of Pride mission statements from around the world, amid approaches ranging from the philosophical to the mechanical, two cities stand out. The Prides of New York and San Francisco, the cities with the longest experience in LGBTI activism converge on four specific objectives, which we distill into three concrete goals for EuroPride 2022:

Teach about LGBTIQ lives

Honour LGBTIQ heritage

Celebrate LGBTIQ culture

Promote LGBTIQ equality



The vision of a pan-European Pride movement will mark 30 years in 2022 since the first EuroPride march took place in London. In 2022, we will celebrate Pride, including pride in our accomplishments as a movement that has changed the landscape for LGBTI individuals in Europe. At the same time, such a landmark anniversary invites us to look forward, to see how we can expand the vision of EuroPride beyond today and beyond boundaries, in order to transform LGBTI lives beyond recognition.





EuroPride creates opportunities for and mobilizes activism by allowing as many stakeholders as possible to join with their own initiatives. The themes and programme above provide a framework to guide and encourage other stakeholders, in particular from the Civil Society Advisory Council, who would like to organise political, cultural and social events that complement the official calendar.





Faith Matters looks at debunking cultural and social stereotypes about LGBTI persons and their opportunity to live truly and publicly express their faith. It acknowledges both sides of the taboo when it comes to religion, gender identity and sexuality, and proposes to have an open, straightforward interfaith debate informed also by discussions during the Vatican's World Youth Day, which Portugal will host earlier in the summer of 2022.

 Proposed speakers: European Forum of LGBT Christian Groups; Confederation of Associations of LGBTQI European Muslims (CALEM) and Rainbow Jews.

HUMAN RIGHTS CONFERENCE

EuroPride will open in Porto with the Human Rights Conference following a weekend-long youth encounter organized by rede ex aequo (see box). The three-day conference will be free to attend, and present keynote speakers, panel discussions, roundtables, informational presentations, and practical workshops. The conference will be conducted by a renowned Portuguese TV host and will be followed by two LGBTI-specialised rapporteurs who will attend workshops and collect notes on key messages. Below, we identify a spectrum of connected topics that span the varied needs of multi-speed progress on LGBTI rights evident across Europe.

Them Us looks at Europe's potential for enabling Human Rights progress in former occupied countries and how, conversely, these countries can equip European LGBTI organisations with a truly integrationist discourse. It recognises the need for Europeans to redress LGBTI communities in former occupied countries and assist other organisations in their work to promote equality and Human Rights. It also recognises that advocacy for LGBTI equality may come at the expense of respecting local cultures and examines the consequences for LGBTI people caught in the middle, for whom asylum abroad is the only option.

 Proposed speakers: Arquivo Identidade Angolano; Commonwealth Equality Network; ABGLT; LGBT Arabic; Organisation for Refuge, Asylum and Migration (ORAM); LGBT Asylum Support; European Asylum Support Office (EASO); UNHCR. Kids These Days looks at the specific needs of LGBTI youth and how they are too often neglected by misconceptions about age. It recognises that today's young people are tomorrow's leaders and family heads, and those who will shape the society of the future. It looks beyond education to acknowledge the full experience of being young and LGBTI.

 Proposed speakers: IGLYO; SALTO-YOUTH Inclusion Resource Centre; International Partnership for Queer Youth Resilience (INOYR). Not OK is OK looks at mental health issues for LGBTI persons. It considers the impact that homophobia, transphobia, biphobia and interphobia have on the well-being of LGBTI persons, on top of the daily negation of living in a heteronormative media environment. It analyses existing services and options for more adequate and appropriate healthcare.

• Proposed speakers: Mental Health Europe; Pink Therapy; EPATH.

Let's Get Physical looks at how sports do and do not accommodate LGBTI athletes. It recognises the gendered nature of sports to date and how this poses particular problems for Trans, Intersex and gender diverse athletes. It reflects on which opportunities athletes are given to come out as LGBTI.

 Proposed speakers: GaySurfers; FARE network; Outsport Project; BJWHF/One Club Fits All.

Purpleconomy looks at LGBTI economic empowerment and at its socioeconomic impact around us. It recognises that LGBTI-owned, -run, and -friendly businesses offer opportunities and influence for people who may not have access to them elsewhere. It examines how business can continue to improve LGBTI autonomy, self-determination, and community, in particular by addressing acute problems in the LGBTI community like youth unemployment, mentoring, and retirement and eldercare. It also addresses negative effects like gentrification, hypertourism and persistent economic exclusion within the LGBTI world.

 Proposed speakers: Nova School of Business; IES Social Business School; B Lab; L'Autre Cercle; OECD; Schwulen Beratung; Rainbold; MisterB&B; OPUS Diversidades.

We encourage diverse voices, including those on narrow and even controversial topics in an open environment that can structure and channel the passionate, sometimes chaotic but always fundamental process of activism. In addition to the official conference, we will list and promote sessions organised by others and connect them with the resources they require, in both Porto and Lisbon, where dedicated Espaço EuroPride venues will include space for events.

INTERNATIONAL YOUTH ENCOUNTER

The International Youth Encounter, part of rede ex aequo's regular programme, will happen in Porto 16-20 September, contiguous with the Human Rights Conference. During the first days, young people from across Europe will get to know each other and explain the work they do in their organisations. Beginning the 20 September, they will attend the conference sessions in Porto, after which they will attend the march and other activities held in Lisbon.

Young people have less budget to travel and participate in events like EuroPride, and their professional and activist networks tend to be limited. As today's young activists will become tomorrow's leaders, it is vital to provide them with tools, knowledge, experiences and networking to empower them from the earliest. The International Youth Encounter thus aims to integrate more young people into EuroPride. We will work with donors and hostels to provide scholarships and accommodation. Young people from all over Europe will find a safe environment to share their experiences, deconstruct prejudices surrounding gender and sexuality, and build their skills and broaden their networks as activists.

MARCH, VILLAGE AND FESTIVALS

The weekend immediately preceding the Human Rights Conference in Porto, and on weeknights of the conference, Porto Pride and a programme of outdoor film screenings will give added incentive for visitors to the city. Further, Porto's student, nightlife and LGBTI neighbourhood offer an array of popular restaurants, bars, clubs and boutiques for many different crowds, tastes and budgets all in close proximity to the EuroPride venues.

In Lisbon, the EuroPride Village will open the last three days of EuroPride on Praça de Comercio, the biggest public square in Portugal: 3.5 waterfront hectares surrounded by colonnades and a triumphal arch. Several dozen stands will offer products, catering, information and meeting places. As a political, cultural, and social agora, the EuroPride Village will dedicate areas for caucuses on youth, families, elders, women, and/or cultural background, who will be the object of proactive outreach. The mainstage will feature nightly live performances to animate open-air parties. Concurrently Lisbon will host the Pitch Beach Athletic Tournament (see box).

On the last day of EuroPride 2022, the March will follow Lisbon's central avenues, it's final leg 2.5 km down Avenida da Liberdade to an enfilade of plazas that lead to the EuroPride Village for the closing speeches, handover ceremony and concert.

PITCH BEACH ATHLETIC TOURNAMENT

Pitch Beach is an international competition that takes place in Lisbon every summer since 2010. It brings together athletes and supporters from over a dozen countries for two sports days during a 4-5 day programme with other social activities. Competition is organised into two categories: (1) Pitch - rugby, volleyball, football and swimming competitions in indoor facilities or grass courts in the city, and (2) Beach - rugby, volleyball and football on a beach near Lisbon. Pitch Beach is hosted and organised by BJWHF/One Club Fits All, a non-profit organisation promoting the practice of sports without any form of discrimination. To date, the group has also established the Dark Horses rugby and Lisbon Crows volleyball teams.



ARTS AND CULTURAL AGENDA

The arts have a particular benefit beyond their thought-provoking and political role. Artwork installations, exhibitions and performances manifest underrepresented identities and issues with a visual impact that conference sessions do not have. Further, they last longer by nature, expanding education and communication opportunities for weeks to months before and after the EuroPride festival. As a result, the arts offer an abundance of visual material for media to use, and can expand media coverage beyond the reductive stereotyping that Pride is about only certain kinds of people or events.

Further, a 2019 meeting of Portuguese curators made clear the widespread desire to include LGBTI narratives in programming. These include both new shows and presentations of existing collections that explore gender, identity, self-expression, love, family, faith, freedom, politics, prejudice, etc., both in artwork explicitly and implicitly, and in the lives of artists. However, while curators from fine to folk art understand that LGBTI narratives can shine new light and help reach new audiences, their directors and trustees doubt the relevance in terms of content and/or growth potential. EuroPride's ability to attract audiences and media coverage would offer proof to the contrary.

At the time of writing, discussion is ongoing with visual, performance, literary and applied arts institutions in cities around the country. The aim is for exhibitions, shows, residencies and workshops to offer a critical mass of LGBTI programming throughout (at least) Portugal's summer high season. As a first step, the Queer Lisboa International FIIm Festival (see box), which would run during EuroPride, have committed to arrange special, public screenings in conjunction with EuroPride in both cities. Additional interest has come from leading museums and the Disquiet International Literary Programme. We will develop these and other options further.



QUEER LISBOA INTERNATIONAL FILM FESTIVAL

Queer Lisboa is Lisbon's oldest film festival and the first Portuguese festival dedicated to LGBTI-themed cinema. Created in 1997, Queer Lisboa has become one of the most internationally recognised of its genre for the quality of programming and activities as well as the guests it attracts. Queer Lisboa gives awards for Best Feature Film, Documentary, Short Film, School Film (short format), and Queer Art experimental formats. In parallel, non-competition sections offer themed programmes dedicated to a particular filmmaker or culture, retrospectives on the historical representation of Queer identity in film, sections dedicated to Queer Cinema subgenres, as well as panel discussions, lectures, workshops, exhibitions, and art installations.

4.PROGRAMME: 6 DAYS, 2 CITIES, 1 DESTINY

EuroPride 2022 Portugal takes place Monday-Saturday, 19-24 September. The Human Rights conference opens the evening of Monday, 19 September in Porto. The EuroPride Village in Lisbon opens to visitors the afternoon of Thursday, 22 September, with a party that night. All week, special rail offers facilitate the 2.5-hour trip between Porto and Lisbon, with capacity added to bring conference goers to Lisbon for the Village opening. EuroPride culminates with the March on Saturday, 24 September, which delivers all to the Village for closing speeches, the handover ceremony, and the main concert.

All week, Porto and Lisbon will each host an Espaço EuroPride mixed-use event space (see box) near the official event venues. This space will house an educational exhibition open to the public and be available to groups wishing to organise meetings and workshops and other events related to EuroPride. Finally, businesses and arts institutions will be engaged to develop a EuroPride-related social and cultural agenda to accompany the political events.

VENUES

Porto and Lisbon, as the country's two largest cities, and its political, social, cultural and economic hubs, are experienced in and well equipped for hosting large, public events. They are only 300 kilometres apart with frequent, direct road/rail (2.5 hrs) and air (30 min) links.

MOBILITY AND ACCESSIBILITY

EuroPride venues were specifically selected for their proven ease of access for people with reduced mobility: ramp entrances, toilet equipped for people with reduced mobility, wheelchair-suitable elevators, priority services and other features.

In Porto and Lisbon, hilly areas with steep and narrow alleys give character to certain older neighborhoods. But the hearts of both cities comprise large, flat, easily navigable zones well served by wheelchair-accessible mass transit and free public lifts to higher elevations. Where these are not available, taxis and ride-share services offer an abundant, reliable and inexpensive alternative.

A silver lining to Portugal's last economic crisis is that new investment redeveloped long-antiquated buildings. Accommodation and facilities that were once inaccessible by dint of age now conform to all modern standards of accessibility, safety and egress. Furthermore, all Human Rights conference events and public speeches will offer Portuguese and International Sign Language interpretation, and audio components of multimedia materials will be created with the visually impaired in mind.


ESPAÇO EUROPRIDE

With events in two cities and activity migrating from one to the other, a sense of presence and continuity in both is essential to the cohesion of a single, national festival. To achieve this, each city will have a mixed-use Espaço EuroPride indoor facility, to be integrated with the official events venues, and serving as a EuroPride anchor or "embassy" in Lisbon during the Porto Human Rights Conference, and in Porto when the centre of activity moves to Lisbon for the EuroPride Village and March.

All week, the Espaço EuroPride, open to the public, will inform people about LGBTI history with a retrospective exhibition about the European Pride movement's work and accomplishments. EPOA member organisations will be invited to provide multimedia content about the LGBTI history and current situation of their country. Local media, schools, associations, and the public will be invited to events at the Espaço EuroPride or to visit them on their own.

As local hubs of the larger EuroPride 2022 festival, the Espaço EuroPride will also hold official receptions and other events, and live-stream video links to conferences and events happening in the other city. Furthermore, the spaces will be available for recognised, independent groups to reserve as a venue for their own presentations, meetings, and workshops organised to complement the EuroPride official schedule.

PORTO

Regular, high-capacity events in Porto include the Red Bull Air Race, World Touring Car Cup Race and, in 2019, the UEFA Nations League football tournament. As the hub for Portugal's industrial north, the city also receives frequent trade shows and organises events like Portugal Fashion week. Porto also hosts the Primavera Sound electronic music festival on the seaside.

With an international airport close to the city centre, well served by mass transit, offering many hotel options, public spaces and alternative routes, Porto's infrastructure can and has handled large crowds with ease.

Porto has multiple indoor and outdoor venues used for international events. The Palacio da Bolsa sits in the historic centre and main area of tourist interest. Its ornate, exotic style creates an exciting and inspiring atmosphere for exhibitions, receptions, and meetings. The nearby University of Porto has numerous state of the art auditoriums and classrooms for smaller sessions. Both are within a few minutes flat walk of Porto's 2-hectare main square, Avenida dos Aliados. This space, used for outdoor cinema, large-screen football viewing, New Year's Eve celebrations and live events, is surrounded by majestic office buildings and grand hotels, and crowned by Porto's City Hall.










LISBON

Lisbon welcomes a constant stream of conventions, festivals and other events. The city hosts the annual Web Summit attracting as many as 70,000 people to the city each year since its move from Dublin in 2016. Lisbon also hosted the EuroVision Song Contest in 2018, receiving more than 50,000 attendees from abroad. Annual music festivals like NOS Alive, Superbock Super Rock, MEO Outjazz attract international headliners and their thousands of fans every summer.

Praça do Comercio is the main city square of 3.5 hectares on the shores of the Tagus river where it widens to form Lisbon's harbour. Here, the annual Arraial Lisboa Pride village and concert hosted 60,000 people in 2019. In 2018, it simultaneously hosted Arraial Lisboa Pride and World Cup football viewings. Immediately adjacent to Praça do Comercio, Patio de Gale is a large, versatile indooroutdoor space, home to Lisbon Fashion Week and, in 2018, the Condé Nast International Luxury Summit. The ornate City Hall is across the street. Tree- and commerce-lined Avenida da Liberdade runs north 2.5 km to Marques de Pombal plaza--the gateway to the old city centre and site of football victory celebrations--where it branches into broad avenues towards newer parts of the city.



5.BUSINESS PLAN: SUSTAINABLE SUCCESS

EuroPride 2022 Portugal public events, including the Human Rights Conference will be free to attend. In addition, our planning includes helping students in particular with accommodations in order to make youth participation a priority.

EuroPride 2022 Portugal will be marketed as a single, contiguous, 6-day festival that begins in Porto and ends in Lisbon. Communications will take a digital-first, substance-first approach, timed with the calendar of European and worldwide LGBTI events from 2019 to 2022. Social platforms (Facebook, Instagram, etc.) will serve for audience-capture and as extensions of the EuroPride 2022 website and app. By going beyond promotion and information to deliver added-value knowledge, we will position EuroPride 2022 as a mustattend event.

Faithful to our Beyond Proud concept for EuroPride to be a positive force for communities, we will design a social and environmental programme to guide our efforts. We will aim to meet B Lab standards for sustainability and inclusivity the full length of our supply and value chains, and encourage our vendors and partners to do the same.

SUSTAINABILITY

Being Beyond Proud also means being exemplary in our impact on the world. That is why EuroPride 2022 Portugal will make controlling its environmental and socioeconomic impact a priority.

The operational specifics will be elaborated with technical experts such as B Lab (see box) to reduce the event's environmental footprint and create positive social externalities where possible. This includes, but is not limited to: reducing/eliminating event swag; prioritizing recycled/recyclable materials; prioritizing mass transit, rail travel, and ride-sharing; prioritizing clean and renewable energy; rules and raising awareness about pollution and waste disposal; prioritizing local sourcing, contracting and human resources to anchor economic benefits in the community; raising awareness about local issues and coordination with housing and social welfare advocates.

Furthermore, the Code of Conduct we establish will apply to our relations with suppliers, partners, and practitioners in order to broaden its impact through network effects.

B LAB CERTIFICATION

B Lab is a non-profit organisation that serves a global movement of people using business as a force for good. B Lab's vision is of an inclusive and sustainable economy that creates a shared prosperity for all. Criteria go beyond product- or service-level certification to measure social and environmental performance. The B Impact Assessment evaluates how operations and business model impact workers, community, environment, and customers. From supply chain and input materials to charitable giving and benefits, B Lab certification protects the highest standards of verified performance, supported by transparency and accountability requirements.



MARKETING AND COMMUNICATIONS

EuroPride 2022 Portugal will be marketed as a single, contiguous, 6-day festival that begins in Porto and ends in Lisbon. ILGA Portugal will lead in communicating with LGBTI social and political action and Human Rights networks across Europe. rede ex aequo will engage with youth organisations involved in LGBTI issues. Variações will be responsible for broader LGBTI consumer marketing and promotion, with the aid of Proudly Portugal (see box).

Consistent with the objectives of EuroPride 2022 Portugal, marketing and communications aim to:


- Inform people about EuroPride 2022 Portugal with regard to the dates, events, travel and accommodation options, and key news about the preparations (e.g. high-profile speaker/performer appearances, etc.)
- Inspire people to attend EuroPride 2022 Portugal with information about EuroPride's spirit of community, contribution, and celebration, as well as about the opportunities visitors will have to express Pride and experience Portugal
- Initiate people's engagement in support of EuroPride (viral effects) with ways to participate in and contribute to the build-up through interactivity (polls, games, contests) and user-generated content

Communications will follow a digital-first, substance-first approach, timed with the calendar of European and worldwide LGBTI events from 2019 to 2022. Social platforms (Facebook, Instagram, etc.) will serve for audience-capture and as interfaces to disseminate news, information, entertainment and other content

from the EuroPride 2022 website and app. Content will lead with stories and issues to introduce and highlight the importance of the people, topics, and other elements of the EuroPride 2022 programme. By going beyond promotion and information to deliver added-value knowledge, we will position EuroPride 2022 as a must-attend event.

While online multimedia content and interactivity drive audience engagement, print formats, influencer outreach, and events will add durable, personal, and tangible reach where digital is less effective. In particular, we will focus on advertising and press coverage in key European and international LGBTI media, and by leading bloggers/vloggers, with particular emphasis on reaching minorities within the larger LGBTI community. We will represent EuroPride 2022 with delegations to EuroPride 2020 Thessaloniki, WorldPride+EuroGames 2021 Copenhagen, EPOA AGMs, and major local Prides in each of the intervening years. Finally, EuroPride 2022 Portugal will feature prominently in the Proudly Portugal presence at LGBTI travel expos ITB Berlin, FITUR, BTL Lisboa, IGLTA and others, and at events in Portugal, such as the Queer Film Festival in Lisbon and Porto, all local prides, Web Summit and others.

COMMUNICATIONS FRAMEWORK



#PROUDLYPORTUGAL

Marketing and communications for EuroPride 2022 Portugal will have access to the resources of Proudly Portugal. Proudly Portugal seeks to establish Portugal as a place where LGBTI tourists, residents, and investors are welcome. EuroPride is naturally an opportunity for Portugal to demonstrate these values in action.

Proudly Portugal asserts, on the one hand, that economic empowerment is a Human Right and an essential part of LGBTI equality. On the other hand, it maintains that diversity and inclusivity bring opportunities for all. It thus uses economic incentives to achieve social goals.

Proudly Portugal launched in 2019, financed by a grant from Portugal's Ministry of Economy Secretary of State for Tourism, and implemented by Variações. This aligns the needs of EuroPride organisers and Portuguese LGBTI organizations with those of the Government to ensure buyin across stakeholders and at all levels.

6.PORTUGAL: #1 IN LGBTI TRAVEL

The ultimate measure of Pride is its long-term impacts. The short-term measure of Pride is size: how mass a statement it makes and how many individual lives it lifts. Size is the product of substance and style.

Renowned for its warm weather and warm welcome, Portugal is among the 20 most visited countries in the world, receiving an average of 13 million foreign tourists annually. Ranked among the five most peaceful countries in the world, Portugal also tied for #1 on the 2019 Spartacus Gay Travel Index. Since five years, Portugal consistently features among Top-10 destinations, on both professional (Monocle, Lonely Planet, Conde Nast Traveller, etc.) and user-generated (TripAdvisor, Airbnb, etc.) lists.

While the need for greater LGBTI social acceptance and legal equality is acute, openness to foreigners and a culture of respect-fulness mean that Portugal remains among the safest, most welcoming places for LGBTI travelers. Lisbon and Porto have dynamic, visible LGBTI presence, and initiatives in smaller cities are multiplying rapidly as evidenced by the local Prides and EPOA members emerging in the last two years.



GETTING THERE

Located in the southwest corner of Europe, Portugal is no more than a medium-haul direct flight from any European country. At the same time, its location makes Portugal the closest European destination to much of the Americas and Africa. Once arrived, Portugal's small size and well-developed transportation systems make travel within the country easy, quick and inexpensive.

AIR

Lisbon and Porto are Portugal's main airports and international points of entry. They offer short- and medium-haul non-stop service to most European cities on a wide array of traditional and low-cost airlines, as well as direct long-haul service to cities in Africa, the Americas and the Middle East. Located mere minutes from their city centres, they both feature easy and safe rapid-transit to downtown or to rail, road and sea hubs for onward travel.

ROAD & RAIL

Portugal boasts one of the world's most modern and comprehensive transport networks. Congestion is rare and distances short, allowing travelers either to move easily along an itinerary or remain in one location with day-trips nearby. Portugal's main rail line runs north-south connecting the major cities. High-speed tilt-technology trains make the run almost hourly, with First and Second Classes, and on-board dining. Less expensive conventional trains run only slightly slower.





HIGHLIGHTS

Porto is a charming, atmospheric city bathed by the waters of the Douro River in the northwest of Portugal. Known as the Invicta, "The Undefeated", Porto is a UNESCO World Heritage Site recognized for its historic character. It is also the departure point for trips through the Douro River Valley wine region on day-sails, longer deluxe cruises, a luxury train, and many more accessible options. The surrounding region, filled with beautiful villages and thriving cities, is a dynamic centre of commerce and industry, which also makes Porto a hub for Portugal's design and fashion excellence.

Lisbon, the colourful capital of Portugal, known for its diverse atmospheres, dramatic landscapes and year-round sun. In 2018, Lisbon won the World Travel Awards for Best Destination City and Best Destination City Break. The city is a contrast study between ancient tiled palaces and modern museum buildings, labyrinthine alleyways and grand avenues, traditional shops and high-concept boutiques, street food and Michelinstar dining, all bound together by centuries of literary tradition and the haunted tones of Fado. Outside the city, from the mountaintop castles of Sintra, to the uninterrupted 30 km curving beach of Caparica, including many LGBTI-friendly and nudist areas, from glittering nightlife to forest yoga classes there is fun for every taste and budget.

EAT, DRINK, SLEEP

As any European city, Lisbon and Porto offer a vast array of accommodations. Dozens of lodgings, from award-winning youth hostels to international-brand luxury hotels, fill the city centers. In addition to these, both serviced and self-catering holiday flats are available throughout the city at a range of prices. With evolving regulations these are becoming less disruptive to local housing and neighborhood dynamics.

Portugal's economic recovery and tourism boom have brought a cornucopia of dining options, from street food to artisanal organic to Michelin-starred gourmet, blending local classics with contemporary reinterpretations and fusions of international influences. And of course wine traditions are ever-present, particularly in Porto's 50+ historic cellars to visit along the city-centre guays.

At night, Lisbon's action is up the hill, around Bairro Alto, whose sleepy daytime alleyways explode in an extended street party that goes long into the night. The hardiest among us can go on from there to the clubs of Principe Real or down along the water-perfect to watch the sunrise. Porto competes with Lisbon as Portugal's LGBTI nightlife capital. Several streets of the historic centre comprise the "gayborhood" with cafés, restaurants and bars where every identity can find their niche.

COSTS

While Portugal's economic recovery and popularity with tourists caused certain prices to rise, it also brought an expansion of options to suit all budgets. It remains one of the EU's lowest-cost travel destinations. At the same time, the country is known to offer good value for money, with high-end restaurant meals rarely exceeding EUR 50/person and mid-price lodging in the EUR 100 range even in high season. Taxis and ride-sharing, and mass transit, including long-distance rail and bus are similarly economical.

Pride is a celebration of our growing numbers, a beacon of hope for those that are looking for a sense of community and a remembrance of how far we have come in terms of vital human rights. I am honored and humbled to be an ambassador to the Portugal Pride candidacy to EuroPride 2022.

I am a senior partner at Bain & Company, one of the world's leading management consulting firms. We work with change-oriented executives to help them make better decisions, convert those decisions to actions and deliver the sustainable success they desire. I have been a partner in Madrid, Lisbon, Sydney and London, and have experienced firsthand how corporations have the ability to be catalysts in the process of making the world a better place for the LGBTQ community.

I have the honor of being the global head of BGLAD, the LGBTQ network at Bain. Our GLBTQ-related policies have created a culture of acceptance and inclusion that is winning outside recognition. For nearly two decades at Bain, we have had a written nondiscrimination policy that provides GLBTQ employees with the opportunity to work as openly and "out" as they feel comfortable. Due to that leadership at Bain – I have been recognized in the "Out at Work" list of the UK's Telegraph newspaper.

In 2007, the Human Rights Campaign awarded a perfect score in its Corporate Equality Index to Bain. We were among the first consulting firms ever to receive this distinction, and have obtained a perfect score ever since. The firm is also rated first in Vault's GLBTQ diversity ranking. I was born into a Portugal under the rule of a dictatorship which used 'traditional' family values as a way to control the people. I went to college and started working in 90s Portugal where there were literally no role models of LGBTQ people and rampant homophobia in daily-life, the news and business culture. The closet (even to oneself) was the only place to live – and where I lived until the 2010s.

A couple of years ago I gave the keynote address at the LGBTI Workforce Inclusion Conference, which took place in Lisbon. Another speaker shared that there are no out executives in any of the top Portuguese companies, be it public sector or private enterprise. Not one. Not a single one. Not that there are no LGBTQ executives – the issue is that society is lagging legislation in acceptance and inclusion. That lack of representation could be significantly addressed by hosting an EuroPride in Portugal. We'd see, feel and enjoy the representation we see across the host countries for EuroPride (or World Pride). Thankfully, it feels like Portugal in the 21st century is a place ready to embrace broader changes and I, for one, believe that EuroPride would accelerate those positive changes.

For those attending EuroPride, it also helps that Portugal has consistently won accolades for tourism and travel, year after year – earlier this month the country won 39 World Travel Awards, 3 more than last year. This year, Portugal received the Best European Tourist Destination for the third year in a row. Among its prizes, it won in a number of hotel categories, like Best Business, Design, Luxury, All-inclusive, and Romantic hotels. The Algarve region won Best Europe Beach Destination, a prize it won five times. Lisbon won the title of Europe's Best City Break Destination. You can't go wrong in picking Portugal.

But it's the contribution to representation and visibility that will leave the lasting marks in helping making the country a better place for LGBTQ people.
